After registration, a member pays monthly contributions (minimum Ksh. 1,000).

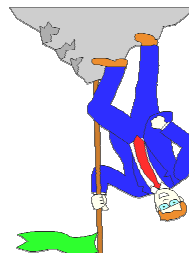
One can now enjoy our wide range of products including training and capacity building, local and overseas exchange visits, business networking and linkages within and without the membership and fellowship with other Christian business people.
